**TABLE-IV-A****In-House Channel Fee for IPTV Service and MMDS Licence  
(Yearly Basis)****IPTV Service**

- i. Maximum of 07 number of in-house / CD channels will be allowed for IPTV Service.
- ii. Region/Zone wise tariff for in-house/CD channels for IPTV shall be fixed based on the number of subscribers in the zone and respective highest category of the in-house channel for cable TV network. However, the applicable tariff may be reviewed biannually based on actual subscriber base.
- iii. The terms & conditions for in-house channels applicable to Cable TV licensees will also be made applicable to IPTV licensees. In addition, it will submit detail of actual subscribers in each zone on quarterly basis.



**Example:** An IPTV licensee for Islamabad zone having 2500 subscribers, the annual in-house/CD channel tariff will be as follows:

**MMDS**

The tariff for in-house channel on cable TV network will be applicable to MMDS operators on the cable TV terms & conditions and on actual subscriber base.
