Each Supplies / bidder shall have to submit bid security @ 5% (refundable) of the bid value in form of Pay Order or Bank Draft in favour of PEMRA H/Qs, Islamabad along-with sealed bid(s). Bids without security shall out-rightly be rejected.

Bids should be submitted in a sealed envelope addressed to the undersigned before 11.00 a.m. on **27 June, 2018** which shall be opened on same day at 11:30 a.m. at 2nd Floor, PEMRA, H/Qs, G-8/1, Islamabad, in the presence of the bidder(s).

Bidders are required to submit the following documents with their offer otherwise their offer will not be considered.

- i. Copy of N.T.N Certificate.
- ii. Copy of G.S.T Certificate.
- iii. Copy of Certificate from Pakistan Standard & Quality Control Authority(PSQA).
- iv. List of clients along with copies of agreement.
- v. Bidders are required to quote their rate inclusive of all taxes applicable at the time.
- vi. Bidders are required to clearly mention the offered packing.
- vii. Physical inspection of water plant may be carried out by tender committee before placing of contract.
- viii. Initially the agreement with successful bidders will be made for two years (2018-19 and 2019-20). However, in case satisfactory service /provision of quality water the contract may be extended for similar provide with the muscatel understanding of both parties.
- ix. Payment will be made on monthly basis as mutually agreed, on Submission of bill along with sale tax invoice/receipts verified by PEMRA Admin wing.
- x. The successful bidder / supplier shall be required to deposit performance Guarantee @ of 5 % of the total bid value.
- xi. 3rd party payment will be made through cross cheque.
- xii. After agreement successful bidder/ supplies will deliver filled water bottles to PEMRA on daily basis on or before 10: 00 am except Sunday and Gazette holidays.
- xiii. In case of poor performance PEMRA can impose penalty on the supplier in the form of deduction of payment up to10 % of bill of concerned period or may cancel the contract
- xiv. The PEMRA reserves the right to withdraw/cancel the invitation of bid at any time without mentioning reason, whatsoever.
